### **Capital Expenditure Programme**

Councillor Macaskill said, that following consideration of submissions on the Regional Council's Annual Plan, the following projects had been brought forward in the Western Regional Flood Protection capital expenditure programme in Council's Long Term Financial Strategy:

- Belmont Edge Protections
- Belmont House Raising
- Bridge Road Edge Protections
- Bridge Road House Raising
- Akatarawa Road Flood Defence/House Raising
- Whirinaki Crescent Stopbank

These additional projects (estimated cost \$3.1 million) would now be completed within the years 2003/04 to 2006/07. Councillor Macaskill also noted that a further \$205,000 per annum had been added to Hutt River maintenance expenditure.

A copy of the overall Western Region Flood Protection capital expenditure breakdown including the above projects was circulated to members.

### HRF94 Hutt River Floodplain Management Plan: Confirming Non-structural Measures

Members discussed the impacts of the non-structural measures on local development and the responsibilities of the Regional Council and the Hutt and Upper Hutt City Councils in promoting the measures in the community.

Councillor Macaskill said that non-structural measures had been embraced by the Kapiti Coast District Council. Following new flood protection structures in Otaki and

Waikanae, the non-structural measures were now under review in that area; the measures were generally working well.

  - (c) notes that the Non-structural Options Working Group requires flexibility to recommend modifying the principles and outcomes, as further non-structural measures detail is developed during Hutt River Floodplain Management Plan drafting.

Mayor Kirton dissented. Councillor Harris abstained.
