  - (a) bringing public transport projects forward into the kick start funding period has a long term positive transport rating effect regardless of any assumption on patronage growth.
  - (b) the assumption made in the Transport Division Operating Plans on patronage growth is critical.
  - (c) information on current patronage growth will be available in late April or early May.
  - (d) it is understood that government are considering ways to ensure ongoing government fund support for passenger transport reflects the need to replace major infrastructure.

- (e) the Council of the day will have available to it the following ways of responding to the developing situation of the patronage funding scheme:
  - 1. Withdraw or accelerate services.
  - 2. Raise or lower rates contributions.
  - 3. Raise or lower fare contributions.
  - 4. Lobby for changes in funding mechanisms.
  - 5. Review policies e.g. on levels of service in the regions Passenger Transport Policy.
  - 6. A mix of the above.
- (f) that officers would report further on whether to include in the proposed Annual Plan 2001/2002 document the public transport kick start projects labeled 4(e) part 2 to 4(i) in the budget Report 01.15 for the 2002/03 year.
