Elected Members' Remuneration - New Ministerial Determination

1. **Purpose**

To seek consider an adjustment to the remuneration payable to elected members in light of the recent ministerial announcement.

2. **Background and Comment**

2.1 Introduction

Councillors are remunerated by way of annual salaries and daily meeting attendances within parameters defined by Ministerial Determination.

The Minister of Local Government has recently published in the New Zealand Gazette a new Ministerial Determination approving a 2.5% rise for salaries and meeting allowances for elected members of local authorities backdated to 16 February 2001. The new Determination prescribes maximum and minimum annual salaries for meetings and also daily meeting allowance rates.

A copy of the new Determination is enclosed at **Attachment 1.**

In summary, the new Determination groups Regional Councils on a population basis as follows:

300,001+ 150,001-300,000 75,001-150,000 up to 75,000

The WRC comes into the first group - Wellington Region having a population of some 429,000.

2.2 **Job Evaluation**

Actual rates payable to WRC members have traditionally been based on a job evaluation and linked to market rates. This Council's use of those processes has produced a satisfactory and objective result. A copy of the letter from Deloitte Touche Tohmatsu advising of the result of the job evaluation process carried out in 2000 is at Attachment 2.

The table below sets out councillors' salaries based on the current Ministerial Determination and the Deloitte's Job Evaluation formula.

As the job evaluation maximum is above the current salary rate paid to all Councillors, a salary adjustment up to the statutory maximum could be considered.

The Council has traditionally paid the maximum rate for daily meeting attendance allowance and all councillors (other than the Council Chairperson) would receive a new higher rate. Daily allowances are also paid to many committee appointees.

3. **Recommendation**

That Council considers applying the amended rates of remuneration to elected members.
