New Zealand's Fresh Water Fish

Councillor Buchanan said Dr McDowall is one of New Zealand's foremost biologists specialising in New Zealand fresh water fishes, in particular native species, and suggested a copy of Dr McDowall's research be published in the Councillors' Bulletin.
