### E 302 Divisional Manager's Report

#### Pauatahanui Inlet Sediment Cores

### (1) Press Release

Councillor Shields requested a press release be prepared on the impact of sedimentation on the Pauatahanui Inlet.

### (2) Co-ordination with Western Corridor Plan Review

Councillor McDavitt noted that the results of the scientific review on the sediment cores will not be available until March 2005. Councillor McDavitt said the Western Corridor Plan Review, a component of the Regional Land Transport Strategy, will be completed before the 2004/05 financial year. Councillor McDavitt said the results of the scientific survey would be of interest to those involved in the Western Corridor Plan Review. Mr Porteous, Environment Co-ordination, said he would investigate ways to provide better linkages between the scientific survey and the Transport Review.

# **CentrePort Appeals**

Luci Ryan, Consents Management, said discussions with CentrePort on the dredging and disposal of material from their inner-berths appeals were progressing well and she was confident of reporting a satisfactory solution to the next meeting of the Committee.

### **Resource Management Seminar**

Councillor Buchanan said he had recently attended a Seminar where Judge Bollard of the Environment Court described changes for the Environment Court over the next six months. Councillor Buchanan said the improvements will have a large impact on the way resource consents are processed and asked that a descriptive note be prepared for the next meeting of the Committee.

Ninety three sites were identified and further investigations are being carried out to assess the impact of the various contaminants in the area.
