Sale of Surplus Land

Councillor Evans referred to the sale of surplus land at Mabey Road and asked how the net proceeds from such a sale are fairly allocated to rates reduction in the region. Mr Schollum said the allocation of such funds depended on the activity which gave rise to the surplus. For example, if the Mabey Road site has been funded by the river rate, the net proceeds from the sale could be used for the retirement of Flood Protection Department Debt.

Responding to a question from Councillor Evans, Mr Wright said there were policies and delegations prescribing the process for the appointment of Hearing Commissioners and Mr Wright apologised a reference to these were not included in the report on today's Council order paper.

Responding to a question from Councillor Barr, Councillor Buchanan said the policies and procedures for the appointment of Commissioners worked well throughout the region.
