E 344 **Presentation from NIWA – New Submarine Fault Discoveries and Revised Probabilistic Seismic Hazard Assessment**

Dr Phil Barnes gave a presentation on the new submarine fault discovery and revised probabilistic seismic hazard assessments according to recent work carried out by NIWA in conjunction with the Institute of Geological and Nuclear Sciences Limited.

Mr R Van Dissen, Geologist, Hazards Group, Institute of Geological and Nuclear Sciences Limited, and Mr N P Ching, Contracts Manager, NIWA were also present.

Mr Barnes said the natural phenomena on the sea floor of the waters in Cook Strait were now more clearly understood following recent research work. While the hazards were not greater than previously thought there was now a better awareness and understanding of the terrain under the sea.

It was agreed that GW needed to give further consideration to the nature and degree of partnership with NIWA during the next few years including additional work on tsunamis. This will be considered in depth when Council reviewed the LTCCP in the new year.
