#### **Resource Investigations – Flood Event 15-16 February 2004**

Laura Watts, Hydrologist, gave a presentation on the flood events of the past two days including photographs of the flooding of the Wainuiomata River, the Waiwhetu Stream, Hutt Park and the Shandon Golf Club.

Mr Evans, Ministry of Civil Defence and Emergency Management, said the flooding had been a significant event. While the Ministry had been monitoring the effects of the storm throughout the north island, Regional Councils and Territorial Authorities had been managing the various civil emergencies and storm impacts with communities at the local level.

Mr Van Schalkwyk, Manager, Emergency Management, said the response to the latest floods had been well co-ordinated and the Ministry, Police, Fire Service and local authority officials had been in close contact and had worked well together.

There is no doubt there will be lessons to be learnt from the events of the past two days and these will be identified during the debriefings that will occur.
