LC 24 **Apologies**

LC 25 Public Participation**Mr Barry Jenness, 26A Hathaway Avenue, Lower Hutt**

Barry Jenness spoke in support of his written submission on flood protection for the Hathaway Avenue area. He stated that the Hathaway Avenue residents wanted Greater Wellington Regional Council (Greater Wellington) to speed up flood protection in the area.

He advised also that if this flood protection work was not done important facilities such as the Hutt Hospital could be affected.

Mr Rod Gillespie, Hutt Golf Club

Rod Gillespie spoke on behalf of the Hutt Golf Club regarding the impact of flooding on the course. He stated that the club wanted a stopbank to be put in place down Harcourt Werry Drive. He requested that Greater Wellington staff help with boundary planting. Rod Gillespie emphasised that the speed with which the stopbank could be put in place, and the placement of the stopbank, were important.

Dr Richard Sadlier, Friends of Belmont Regional Park (Inc)

Richard Sadlier suggested options for Greater Wellington in financing the purchase of Waitangirua farm. He stated that the Friends of Belmont Regional Park (the Friends) are very keen for Greater Wellington to acquire the farm. Dr Sadlier suggested that Greater Wellington should ask to have the farm valued as an ongoing farming operation as opposed to the highest and best use. Richard Sadlier advised that the Friends would remove its potential opposition to the establishment of a wind farm at the park if Greater Wellington purchased the farm. He advised that the Friends would want a letter of understanding from Greater Wellington to assist the Friends in this regard.

Councillor Laidlaw suggested the following to the draft Terms of Reference:

The fifth bullet point under Heading 4 Objectives should have the following words added to it (amendment in italics):

“ensures that methods adopted to mitigate the effects of flooding consider and integrate with the Waiwhetu Stream and its environment, recognising its unique nature and the role it plays in the life of the communities. In particular a high level of integration with the existing Waiwhetu stream rehabilitation programme.”

This would provide a clearer link between the Waiwhetu floodplain study and the rehabilitation programme.

*Resolved**(Cr Buchanan /Cr Shields)*

- (1) That the formation of a joint Advisory Committee to progress the Waiwhetu Stream Floodplain Management Study, which would be a subcommittee of the GWRC’s Landcare Committee, be agreed.*
- (2) That the proposed Terms of Reference as amended, for the Waiwhetu Stream Advisory Committee (Attachment 2,) for consideration by the Advisory Committee at its first meeting, be endorsed.*
- (3) That it be noted that the Waiwhetu Stream Advisory Committee will meet approximately quarterly and meeting dates are yet to be confirmed.*
- (4) That it be agreed that Stuart Macaskill be appointed as the independent chair of the Waiwhetu Stream Advisory Committee.*

- (5) *That three elected members, Councillors Laidlaw, Glensor and Greig (with Councillor Evans as alternate) be appointed to the Waiwhetu Stream Advisory Committee.*

He stated that if Landcorp proceed as they have indicated using the land for housing is most likely which would be the least desirable option for Greater Wellington. He confirmed several options for the use of the farm land:

- single block in public ownership;
- working farm;
- wind farm;
- housing.

Councillor Shields confirmed that she would prefer the farm stays in public ownership

Councillor Buchanan stated that he and Councillor Laidlaw would be having a meeting with Conservation Minister Chris Carter next week to discuss the possibilities for future ownership of the farm. He advised that at the same time they would explore a number of other options with the view to maintaining the integrity of the regional park.
