# **Appointment of Harbours' Enforcement Officers**

### 1. Purpose

To appoint enforcement officers to carry out duties under the harbours provisions of the Local Government Act 1974 and the Navigation and Safety Bylaws for the Wellington Region.

## 2. Significance of the decision

The matters for decision in this report do not trigger the significance policy of the Council or otherwise trigger section 76(3)(b) of the Local Government Act 2002.

# 3. Background

Under section 650B of the Local Government Act 1974 regional councils can appoint enforcement officers for the purpose of carrying out the powers, functions and duties specified in Part 39A (Attachment 1). Under the Council's Navigation and Safety Bylaws for the Wellington Region the Council has the role of appointing enforcement officers for the purpose of enforcing the Bylaws.

The Council last appointed harbours' enforcement officers in 2000 and 2002. Since then new bylaws have been adopted and there have been some changes to members of the Wellington Police Maritime Unit. This makes it a good time to review the list of enforcement officers.

#### 4. Comment

We recommend that the Council appoint the people in the table below as enforcement officers to carry out the powers, functions and duties specified in part 39A of the Local Government Act 1974, and to enforce the Navigation and Safety Bylaws for the Wellington Region.

Many of the proposed enforcement officers are members of the Police Maritime Unit. This Unit has assisted the Council for many years in controlling

and regulating water activities in the region. They have a regular presence on the harbour and are fair and reasonable in their approach to safety and water.
