Paula Warren is of the opinion that transport investment decisions are important as they can't be easily changed if mistakes are made. She predicts major change in transport and land-use patterns, which requires an effective response. Paula maintains that the NLTP, 10-year SH Forecast, Ontrack's plans, and the RLTS don't provide that response, and suggests changes are required in the short term.

Brent Keith told the Committee that he felt that Tranz Metro's service is being compromised by the unreliability and shortage of rolling stock. He urged Greater Wellington to solve the problem by purchasing second-hand EMUs from Japan. He also addressed other issues including electrification voltage and platform height.
