Chris Horne recommended that the Dowse to Petone Grade Separation (Hutt Corridor) and other planned new link roads be abandoned as they ignore the threat of climate change, peak oil, and the Government's draft energy strategy. Mr Horne also requested that the Committee withdraws the draft Wellington Regional Land Transport Strategy 2007-2016.

Adrian Webster welcomed the draft Wellington Regional Land Transport Strategy 2007-2016, and said he appreciated the opportunity to make submissions on it. Mr Webster suggested that both road and rail should form part of travel demand management to alleviate shortage of trains on the Kapiti coast route at peak times. He feels that Wellington employers should utilise flexi-time to lessen the peak commuter load.
