PT 134 **Public Participation****Tabled**

“Input to Passenger Transport Committee meeting 27 March 2007” Paula Warren.

“Public Participation Passenger Transport Committee Meeting Tuesday 27 March 2007” Rail and Maritime Transport Union Inc.

Paula Warren

- voiced her support for double tracking from MacKays Crossing to Lindale
- applauded the ordering of new EMUs, but feels that an insufficient number has been ordered
- favours the retention of Matarawa Station
- feels that bus service disruptions are due to a number of factors
- attributes long dwell times at bus stops to the inefficient ticketing system being used.

Howard Phillips, on behalf of the Rail and Maritime Transport Union

- feels that Greater Wellington needs a clear infrastructure plan to cover the next 30 years
- supports the retention of all existing stations.

Rob Paris spoke in support of retaining the Matarawa station, and suggested that it could be upgraded at a lower cost than the estimates presented to Greater Wellington.
