## 9 Wellington Hospital Water Supply

Chris Laidlow, Wellington Water Limited, updated the Group on the proposed plans for emergency water supply following a seismic event. It is predicted that it could take up to 20 days for water supply to be up and running, with the possibility of only 5 - 10 days of water left in the reservoirs. As Wellington City and Porirua City will be the longest without water due to geographical factors, it is proposed that emergency water supply will consist of a combination of storage reservoirs in Wellington and a pipeline across the harbour floor. The Group discussed the resilience of the pipeline and noted that the proposed pipe would be made from flexible polyethylene and that engineers are confident that it will withstand any movement on the harbour floor.

## **10 AOTEA Fault**

The Group received a presentation from Dr Phil Barnes from NIWA on the Aotea fault, underlying Lambton Harbour. The ground shaking hazard from the fault is already accommodated in the present National Seismic Hazard Model and Building Code however; possible surface rupturing on the fault is a hazard that warrants consideration. Further research

is needed to improve seismic risk assessment, define the fault location on land and to incorporate it into urban planning. This will be carried out by GNS Science and NIWA and includes a first phase of determining the on land location of the fault and a second phase of marine surveying to determine the crustal nature of the fault.
