 Procurement of Public Transport Services under the Public Transport Operating Model

Certain information contained in this report relates to potential future rail service contracting in the Wellington region. Release of this information would be likely to harm the commercial position of Greater Wellington Regional Council (GWRC) and also harm the commercial position of current providers as it sets out potential options which if adopted might providers expose current commercial risks. GWRC has not been able to identify a public interest favouring disclosure of this particular information in public proceedings of the meeting that would override the need withhold the information.

That the public conduct of the whole or the relevant part of the proceedings of the meeting would be likely to result in the disclosure of information for which good reason for withholding would exist under section 7(2)(b)(ii) of the Local Government Official Information and Meetings Act 1987 (i.e. to protect information where the making available of that information would be likely unreasonably to prejudice the commercial position of the person who supplied or is the *subject of the information).*

2. Permit Alex Guy, Partner, DLA Piper and Robert Buchanan, Probity Advisor, to remain at this meeting after the public has been excluded because of their knowledge relating to the procurement of public transport services under the Public Transport Operating Model. This knowledge, which will be of assistance in relation to the matter to be discussed, is relevant to that matter because it is the subject of the report.
