4 Resilient Cities 100

The Group received a presentation from Mike Mendonça, Chief Resilience Officer, Wellington City Council on Resilient Cities 100. The 100 Resilient Cities (100RC) organisation is part of a \$164 million investment by the Rockefeller Foundation to build urban resilience in 100 cities around the world. The aim is to help cities around the world become more resilient to physical, social, and economic challenges.

Workshops have been held across the Wellington Region and have identified 6 focus areas:

- Earthquakes
- Climate change
- Economy
- Housing (including social housing)
- CBD growth
- Connected and engaged communities.

The CDEM Group requested that the Wellington Lifelines Group be invited to brief the Group on how its planning relates to the work being done by Resilient Cities 100.

5 Wellington Water Resilience Planning

The Group received a presentation from Mark Kinvig, Group Manager Network Strategy and Planning, Wellington Water on Wellington Water Resilience Planning.

Wellington Water is working under the framework of resilient cities and planning for two different types of scenarios:

- The worst case scenario, such as a major earthquake; and
- Day-to-day operational resilience, such as a failure of equipment.

The Group was advised that Wellington Water is working on education for self-storage for emergencies, fire-fighting and the reticulation network.

Emergency Management Activation Process

The Group received a presentation from Craig Hamilton, Manager Operational Readiness, Wellington Region Emergency Management Office on the emergency management activation process.

There are two different types of activations:

- Self activation, for spontaneous events such as a major earthquake; and
- Planned activation, for events where there is some forward notice such as weather.

He explained the procedure from a duty officer receiving notice of an event through to the Emergency Operations Centre (EOC) developing an initial action plan. Notifications of events are provided to Mayors, Council Chief Executives, Emergency Services and other key parties.
