Processing of your application will only commence once the correct initial application fee is paid in full.

The initial fixed application fees are set at the average cost for processing various consent types. GWRC charges the actual and reasonable cost for processing any application. GWRC staff time is charged at the rates shown below:

Resource management services including consent registration, database entry, and notified consent processing support	\$120.00 (excl. GST)	\$138.00 (incl. GST)
Consent processing services including assessment of consent applications, decision recommendations	\$140.00 (excl. GST)	\$161.00 (incl. GST)
<b>Technical or science expert services</b> for technical and/or science expert advice. (Note: Where external expert services are required, the full cost is charged.)	\$155.00 (excl. GST)	\$178.25 (incl. GST)

If the cost is less than the initial fixed application fee you will receive a refund. If the cost is more than the application fee, additional charges apply. Where additional charges are likely to be significantly more than the application fee, we will advise you when your application is being processed.
