Request for information 2022-079

I refer to your request for information dated 14 June 2022, which was received by Greater Wellington Regional Council (Greater Wellington) on 14 June 2022. You have requested the following:

“For all calls made regarding odour from Spicer Landfill between 1 November 2021 and 14 June 2022 please provide the response time for each call. By response time I mean the time from when the call is logged until a GWRC compliance officer is on site where the odour was detected. If there are multiple calls about the same odour incident, then the response time from the first call will suffice.”

Greater Wellington’s response follows:

Attached is the spreadsheet of complaints about odour from Spicer Landfill recorded in Greater Wellington’s Ozone database from 20 April 2022 to 14 June 2022. Please note the search term ‘spicer’ was used to identify these records (refer **Attachment 1**). Please note that the timeframes for this data was determined to provide the record of calls from your previous request for information (2022-040) up until the current request.

We have withheld information pertaining to names, contact details, and addresses of notifiers under section 7(2)(a) of the Local Government Official Information and Meetings Act 1987 (the Act) in order to protect the privacy of natural persons, including that of deceased natural persons.

We have considered whether the public interest in the requested information outweighs Greater Wellington’s need to withhold certain aspects of the requested response times. As a result, we do not consider that the public interest outweighs Greater Wellington’s reason for withholding parts of the document under the grounds identified above.

In regard to the response times, we have refused this part of your request under section 17(f) of the Act on the basis that the information requested cannot be made available without substantial collation or research.

This is because there are 174 odour notifications received in relation to 'Spicer' landfill between 01 November 2021 and 14 June 2022. The responses of each individual duty officer will not be saved consistently, will in some cases be only available in the duty officer's personal files and notes, and in some cases the data will not be recorded at all. Over the period of time requested 12 different Enforcement Officers have received calls about Spicer Landfill while on duty, some of these Officers no longer work for Greater Wellington's Environmental Regulation department. Therefore, compiling this information would require a number of secondary searches and substantial compilation and even then would not result in a complete picture of the response times.

We have considered whether inviting you to refine your request, extending the timeframe, or charging you for the supply of the information would be appropriate in this instance. We have formed the view that these options would not mitigate the significant administrative impact on Greater Wellington's operations that fulfilling this part of your request would entail.

If you have any concerns with the decision(s) referred to in this letter, you have the right to request an investigation and review by the Ombudsman under section 27(3) of the Local Government Official Information and Meetings Act 1987.

Please note that it is our policy to proactively release our responses to official information requests where possible. Our response to your request will be published shortly on Greater Wellington's website with your personal information removed.
