

Judge Thompson practised in Wellington and Blenheim from 1974 until being appointed Crown Counsel in the Crown Law Office in 1983. In 1985, he was made Deputy Solicitor-General for New Zealand.

He was a member of the legislation advisory committee from its inception in 1986 until he was appointed as a District Court judge in 1992. He was appointed as an alternate Environment Court judge in 2001, becoming a full-time Environment Court judge in August 2003.

Glenice was appointed to the Environment Court as Deputy Commissioner in 2017, an accredited Commissioner and Mediator. She has a background in the conservation and resource management fields and has held appointments on various Environmental Protection Authority Boards of Inquiry, including Tauhara II Geothermal Power, Transmission Gully and the Mackay's to Peka Peka Expressway. Glenice has an extensive background in leadership and governance within Iwi/Maori organisations. Glenice is Co-Chair of Mana Rangatira (Governance Group) of the National Science Challenge Biological Heritage, and also Co-Chair of the Knowledge Advisory Group (KAG) addressing Kauri Dieback and Myrtle Rust threats to our taonga. She recently completed three terms on the Nelson City Council Environment and Climate Change Committee. Additional previous roles include being a member Te Tau Ihu Rivers & Freshwater Advisory Committee, and a directorship on the South Island whanau ora commissioning agency, Te Putahitanga o Te Waipounamu General Partner Ltd. Glenice affiliates predominantly to Te Atiawa Te Tau Ihu and Ngai Tahu.
