Greater Wellington Regional Council is looking for a person with appropriate skills and experience to serve as the external member and Chair of Council's Finance, Risk and Assurance Committee.

The Wellington Region covers a geographical area in excess of 8,000 square kilometres of the lower North Island - the northern boundary runs from north of Ōtaki on the west coast across to north of Castlepoint on the east coast. Council is responsible for a range of activities and services including public transport, environmental management, flood protection, harbours, and the supply of bulk drinking water to the four city councils within the Wellington Region.
